Wessex Water Services Limited (in this order called 'the acquiring authority') makes the following order

- Subject to the provisions of this order, the acquiring authority is under section 155 of the Water Industry Act 1991 hereby authorised to purchase compulsorily the land off Mead Lane and adjacent to and to the west of the Saltford Recycling Centre and the River Avon described in paragraph 2 for the purpose of:
 - (a) constructing extensions alterations and/or improvements to the existing Saltford Recycling Centre (SRC) to increase the Flow to Full Treatment capacity of the SRC
 - (b) mitigating the adverse effects which the existence or use of the works proposed to be constructed altered and/or improved will have on the surroundings thereof
- 2 The land authorised to be purchased compulsorily under this order is the land described in the Schedule and delineated and shown coloured pink on a map consisting of 1 sheet prepared in duplicate, sealed with the common seal of the acquiring authority and marked as 'Map Referred to in Wessex Water Services Limited (Saltford Water Recycling Centre Extension) Compulsory Purchase Order 2023".
- 3 In this order all measurements of areas stated in any description of the lands shall be construed as if the words "or thereabouts" were inserted after each such measurement of area.
- Parts 2 and 3 of Schedule 2 to the Acquisition of Land Act 1981 are hereby incorporated with this order subject to the modifications that references in the said Parts 2 and 3 to the undertaking shall be construed as references to the works constructed or to be constructed on that part of the land authorised to be purchased on the said map.
