# Do you qualify for a rainwater drainage allowance?



You pay a charge for rainwater draining from your roof, driveway and other parts of your property to our sewers. Rainwater can overwhelm some sewers during intense rainfall and result in storm overflows operating.

Most customers are connected to a surface water sewer or combined sewer, which take away rainwater.

You may be entitled to an allowance if you receive sewerage services from Wessex Water and none of the rainwater from your property returns to our sewer. In this case the rainwater normally drains to one or more of the following.

- A soakaway this is a concrete or plastic underground chamber, or pit filled with gravel or stone. This would usually be within the boundary of the property, at least 10 to 15 feet away from the property.
- A watercourse via private pipework. For example, a stream, pond or the sea.
- A rainwater harvesting system if the recycled water is used for garden irrigation none will be returned to the public sewer, and an allowance is due. Where the recycled water is used for domestic purposes (eg, toilet flushing) and then returned to the sewer, no allowance will be due.

If you are unsure whether you are connected to the public sewer you can check where the rainwater from your gutters goes. If there is a sewer close by you may find evidence of this, such as a heavy duty manhole cover. If this is the case then it is likely that rainwater from your property drains directly to the sewer.

## Rainwater drainage allowance - your questions answered

#### How much is the allowance?

The average amount of the allowance is £27 per year for a household customer. For unmetered customers the amount varies according to your rateable value.

## If I am entitled to the allowance, will it be backdated to cover previous years?

Yes, either:

- by six years\*, or
- to the date you became responsible for charges for the property\*, or
- to the date the property was disconnected from the company sewer system for rainwater.\*
- \* whichever is most recent

## The water from my roof at the back of the house goes to a soakaway. At the front it drains to the sewer. Can I claim an allowance?

No. You only qualify for the allowance if no rainwater enters our sewers. There is no reduction for partial drainage, for example, some water enters a soakaway and some rainwater enters our sewer.

## I don't have soakaways but I use a water butt to collect water from the roof. Can I claim an allowance?

No. Having water butts doesn't mean you can claim the allowance as they can overflow and usually don't collect all the water from a roof. But the allowance may apply if you can disconnect downpipes and connect them to water butts, with surplus water being distributed across your garden or into a soakaway.

### If I am eligible, do I need to apply each year for this allowance?

No. The allowance will be automatically deducted from all future bills for that property.

#### How do I apply for the allowance?

Simply complete the application form on page 3 or apply online. Please note that we may visit your property to check the rainwater drainage.

#### Do I need to pay to apply for the allowance?

No. It's free if you complete the form on page 3 and send it directly to us. There are some companies that offer to apply on your behalf, but generally they charge for this service.
